## "WESTERN BALKAN'S CHALLENGES IN STRENGTHENING RULE OF LAW AND FIGHT AGAINST CORRUPTION AND CRIMINALITY"

#### **Object of the conference:**

Western Balkans is the only part of Southern-eastern Europe which has not joined the Union yet, even though the block has affirmed the European future for all these countries. Nevertheless, irrespective of recent approaches toward integration into the European Union, also due to significant differences and other obstacles, there is a support for vis—a—vis approach or merits-based performance of each country. On the other side, irrespective of differences, even though sometimes not minor, the main obstacles for admission are related to fulfilment of membership criteria determined by Council of Europe in Copenhagen in 1993, which were further detailed by European Council in Madrid in 1995, and continue to be the same, in their type and content, beside non-significative differences in the way they are developed and special characteristics of respective countries. The entire region with a former communist past inherits numerous problems, but the most difficult problems to overcome remain strengthening of rule of law, fight against corruption and criminality, in general.

From the point of view of rule of law, most concerning problems are violation of check and balance principle, violation of constitutional equilibrium, frequent failure of law enforcement process to protect the public interest, protection, respect and promotion of human rights, existence of independent, unbiased, professional and responsible of judicial power, elimination of discrimination for vulnerable groups, implementation of international law obligations, etc. Meanwhile, corruption remains in the highest levels compared to the EU countries and in many cases presents systemic features and in dimensions that violates the essence of rule of law and protection of public interest in general. Corruption, due to its special nature, violates not only respective social relations, but also the general capacity of state to fulfill its mission including a decrease of the capacity to fight criminality and many other issues. Efforts to fight corruption and criminality in the Western Balkans and especially in the Republic of Albania are in an important phase, where law enforcement structures have considerably boosted capacities and the response of judiciary to these phenomena is really promising. Likewise, legal framework approved in Albania regarding special structures against corruption and organised crime and the example of work of respective bodies can be considered as a model beyond the Republic of Albania. Nevertheless, challenges to set the missing EU standards continue to exist for the entire WB, not only Albania, i.e. it is necessary to work hard and have an all-inclusive approach to transform the current situation and meet the EU membership requirements. Among the things, in order to face such challenges is necessary to have a developed educational system and study programs which ensure not only human resources, but also create social conditions for a natural EU integration and not a forced and formal integration.

This conference shall have a plenary panel and three special panels, divided according to three departments of the Faculty of Social Sciences: *Panel of Legal and Political Sciences, Panel of Education and English and Psychology Panel.* 

Attending the conference shall be invited guests from the following institutions:

- Special Prosecution against Corruption and Organised Crime,
- Supreme Court.
- Constitutional Court.
- Kosovo Constitutional Court.
- Kosovo Academy of Science.
- Albanian Academy of Sciences.
- University of Prishtina.

Likewise, attending the conference will be guests from University of Zagreb and other regional universities, well-known experts of Western Balkans affairs, representatives from University of Bologna, Helsinki Committee for Human Rights in Serbia etc., as well as representatives of the diplomatic corps accredited in Tirana. Participating with presentations at the conference will be scholars and academic staff members of higher education institutions in Albania and other countries that wish to participate, following the admission of their from the Scientific Committee of the conference.

All interested authors are encouraged to contribute and help in realisation of this conference with their scientific research works by sending an abstract of the full paper, poster or virtual

presentation in the English and Albanian language. Due to internationalisation purposes, we encourage presentations in English Language.

#### **Participation and Publication:**

Presentations at the conference shall be subject of a preliminary blind peer review process by members of the Scientific Committee and other persons assigned by the Committee and shall be published in the Book of Proceedings, as well as in the journal Albanian University "Optime" with a consideration for a potential cooperation with a SCOPUS indexed journal where the publication shall be carried out based on individual merits of each work presented and accepted at the Conference and shall subject of journal its own admission criteria.

Participation at the conference shall be free of charge and those who would like to receive a hard copy of conference proceedings shall be required to pay a fee of 10 Euro/ copy.

# Admission criteria of paper:

Each paper proposal that will be accepted for publication shall undergo the peer review process by two experts from the relevant field of study of the paper. The paper shall be published if both reviews are positive. If one review is positive and the other one negative, the article is sent for review to a third reviewer, who shall decide on acceptance or refusal of the paper. Thus, the responsibility for selection of scientific papers is an exclusive competence of anonymous reviewers. The publication costs in journals not belonging to Albanian University, shall be covered by contributors themselves (authors), according to the volume of each paper or from the affiliated institution in accordance to Journal criteria itself.

Each paper shall be following language standards. Papers may consist of scientific works, reviews, original creations or translations.

#### Structure of scientific presentations shall be as following:

- (1) Title up to 15 words;
- (2) Author(s) (name, surname); affiliated institution; electron address (es);
- (3) Data on the author(s), 4-6 lines, as a text;
- (4) abstract (Albanian, English), 200-250 words and 4-6 keywords
- (5) text of the paper (accompanied with shortened references during the text).
- (6) Standard length for articles 8 computer pages.
- (7) Full references at the end of text according to alphabetic order of authors surnames;
- (8) Each paper shall be submitted in the word format.

[Note 1: Summary/abstract shall include: theme/topic of this work, research questions, theoretical approaches, methodology/concrete applied methods, findings/results and conclusions]
